

2025 Eduardo Diaz Union-to-Union International Solidarity Fund

Administrative Procedures

Dates of the Program & Assigned Quotas

The 2025 Union-to-Union Program will be conducted on a calendar year basis beginning January 1, 2025, through December 31, 2025. The Union's Convention established a minimum Union-to-Union quota of at least \$.10 per member per year. This quota is based on the previous year's October Membership Opportunity Report (i.e., 2025 quotas are based on the 2024 October Membership Opportunity Report).

Contribution Options

3. **Pay monthly via dues processing (Note: 100% Local Collection and cash only units are not eligible for dues deduction).**
 - a. Deductions from top-down units only.
 - b. Monthly billing by PU for bottom-up units (not all charities available, see list below)
 - i. Pediatric Aids
 - ii. Union to Union
 - iii. Retired Members Council
 - iv. Joseph Beirne Memorial Fund (IUE, TNG Only)
 - v. TNG Defense Fund (TNG Only)
 - c. Contribution reports available on Aptify
 - i. Active Local Charities report, what is set up for deduction
 - ii. Local PU Fund Contribution report, how much has been contributed
 - d. Fill out the MLO-124 form and email to duesquestions@cwa-union.org
 - e. MLO-124 Form Link
 - i. Pay a flat amount per month (top two rows below)
 - ii. Pay an amount per paying member per month (third row below)
 - iii. Maximum annual amount can be set (first and third row below) **

4. Send a check for the full quota amount(s)

Locals will be provisionally billed for the quota amounts in Aptify each year unless they are already paying via dues deduction, or have opted out of the program altogether. Quota invoices will show on the **Open Invoices** report on the Aptify portal.
