## General Information

The CWA Constitution, Article VIII, Section 1, provides that the Union shall meet in Biennial Convention at a place selected by the Executive Board or the Secretary-Treasurer when authorized by the Executive Board to do so.

Section 3 of the same Article provides that all Locals be notified in writing of the date and place of the Biennial Convention no later than 90 days in advance of the opening date of the Convention.

Therefore, this is to advise that the 80th CWA Convention will be held at the David L. Lawrence Convention Center, beginning at 9 a.m. on Monday, August 11, 2025.
