I have verified with the Verizon field technicians and there is no Verizon cable going on SW 1<sup>st</sup> Court from 21<sup>st</sup> Terrace to 22<sup>nd</sup> Avenue. The current cable crosses I-95 just north of the rail platform into the rail road right-of-way then goes north and south; not leaving the rail property.

We have an existing fiber optic duct bank (1-2" HDPE Conduit) along the fence that was installed by World Fiber Technologies in January of 2010, and is why you see our locate flags. Another push button contract also installed some conduits in that area that completed March of 2016. Due to the work being performed now, it is not related to the Arterial ITS system.
